REQUIREMENTS

The Monterey County Sheriff's Office Ride-Along Program is offered to residents, students and those employed within the county. Every attempt will be made to accommodate interested persons; however, any applicant may be disqualified without cause. The following factors may be considered in disqualifying an applicant and are not limited to:

- Must be at least 16 years of age
- Must drink no alcoholic beverages prior to riding
- Minors must have a release form signed by parent/guardian
- Sign Liability Waiver prior to riding
- Must be in good health
- Prior criminal history
- Must dress neatly and conservatively
- Pending criminal action
- No firearms, cameras or recording devices will be allowed
- Pending lawsuit against the Office
- May participate in only **ONE** ride every 6 months
- Denial by any supervisor
